
#### **The Company**

The system establishes a direct connection between **forwarder users and airline operators**, allowing shippers to receive immediate booking space confirmations from airlines.



- 2. Once the shipment arrives at destination, transporter/forwarder clear customs and deliver shipment to warehouse location selected by shipper


3. Shippers can seamlessly arrange domestic transport to the consignee's address using Mahyu's domestic transport feature, along with instruction to warehouse operator.




## **Administration for Partner and Shipper Users**

Each partner can manage the financial aspects of shipper users, allowing them to grant flexible credit lines or enable online payment options based on user eligibility and history record.




Partners can **review** each shipper's performance, including current and past sales activity summaries, to assess their business engagement.




### **Administration For Transporter and Setting Menu**

when transacting with transporters. This

and regulatory.




#### **Consumer User & Non-Qualified Business User**

#### The Administration Feature-Connecting and Monitoring

The **Transporter User** consists of the following steps:

- **1.Registration Process** Transporter users sign up on the platform.
- **2.Submitting Credentials** Upload necessary identification and authorization documents.
- **3.Submitting Company Information** Provide details about the company, including legal and operational information.
- **4.Build Up Services Capability** Define available services, such as freight handling, customs clearance, or last-mile delivery.
- **5.Services and Pricing Information** Set pricing structures for the offered services.
- **6.Perform Transactions** Start processing shipments and handling logistics operations.
- **7.Summary Reports** Access performance reports and analytics for business insights.

The **Shipper User** consists of the following steps:

- **1.Registration Process** Sign up on the platform as a shipper.
- **2.Submitting Company/Individual Information** Provide necessary details, including business location, names
- **3.Submitting Financial Information** requirement of credit line limits
- **4.Build Up Logistics Requirements** Define shipment details
- 5. Receive Transaction Notification.
- **6.Perform Invoice Payment** Complete invoice payments via credit line (if eligible) or online payment (QR code for Southeast Asia, credit card for other regions).
- **7.Review History Records** Access past shipments, payments, and transaction summaries for tracking and reporting.
